# MINUTES OF THE 21st STATE LEVEL SECREENING COMMITTEE MEETING FOR SCREENING AND SELECTON OF THE CANDIDATES APPLIED FOR SANCTION OF FINANCIAL ASSISTANCE UNDER Dr.B.R. AMBEDIAR OVERSEAS VIDYA NIDHI SCHEME FOR THE YEAR 2023-24

The State Level Screening Committee for selection of eligible ST students for sanction of financial assistance under Dr. B.R. Ambedkar Overseas Vidya Nidhi Scheme met on 15-03-2024 from 11.00 AM onwards at Mini Conference Hall, 1<sup>st</sup> floor, DSS Bhavan, Masab Tank, Hyderabad.

At the outset, the Chairman, SLSC & Secretary to Government, Tribal Welfare, TS has explained the guidelines of Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme as laid down in G.O.Ms.No.36 Tribal Welfare (Edn.-2) Department, Dt.04-06-2013 and G.O.Ms.No.62, Tribal Welfare (BUD & EDN.) Department, Dt.26.08.2021 and also the process to be followed in selection of ST students for sanction of Financial Assistance to pursue higher studies in Foreign Universities, namely USA, UK, Australia, Canada, Singapore, Germany, New Zealand, Japan, France and South Korea.

The SLSC examined the (195) applications, pending for consideration and during the discussion, the TWD officials have also brought certain additional points for examination and consideration in appropriate manner.

# SLSC examined the following Agenda and decisions taken are as follows:

## (i) Sanction of AOVN Schemes for the year 2023-24:

(a) There are (232) students have registered in e-pass portal and all have been scrutinized and on scrutiny, (195) students / applications are with sufficient and required documents and (37) applications are not with sufficient documents / credentials for verification.

(b) It is further submitted by Addl. Director & his team of officials that as against (195) applications which are scrutinized, (27) applications are kept aside for time being due to the following reasons:-

and also informed that (42) applications are found ineligible for the following reasons:

(c) For 21<sup>st</sup> SLSC, (15) applications can be considered for sanction of AOVN scholarships for the year 2023-24 against the target of (100), as (85) already considered by the SLSC in their previous meetings.

### (d) Therefore, SLSC, after detailed examination, the following decision taken.

- 1. On examination by SLSC, found that as against (195) applications, (42) are ineligible for sanction of AOVN scholarships has been rejected (Annexure-II).
- 2. SLSC after detailed examination and decided to consider (15) eligible applications as per merit in the eligible list of (153) applications (Annexure-I) and further decided that if any candidate in-between against the merit list with insufficient documents will be given notice to submit relevant documents and their cases will be examined for consideration or rejection after examination of relevant documents.
- 3. The SLSC further discussed in detail, about remaining (138) applications which are found eligible for which it is felt appropriate that to send proposal to Government for sanctions of AOVN Scheme Scholarships against the budget earmarked for the year 2024-25 for which Director, TW to send necessary proposals.

#### (ii) Consider the applications which are with gap period between Graduation to PG.

(a) The TWD Officials have brought to the notice that the previous SLSC has rejected/not even called for interview for (19) candidates (Annexure-III) on account of Gap period from Graduation to Post Graduation which is being represented by various Associations and Students/Parents that this is against the Govt. norms.

(b) The same has been examined by the SLSC and observed that this Gap period between

Graduation & Post Graduation should not have been considered for ineligibility, as it is not

being adopted by any other Dept., i.e., SCDD/BCWD, as well as on examination of Govt.

Orders also, it does not specify any thing in this regard.

Therefore, SLSC decided to consider eligible applications which were rejected and

pending now with gap period, if they are in merit for this year 2023-24 and balance

applications (Annexure-III), proposals to Govt. for consideration in financial year 2024-25, by

the Director, Tribal Welfare.

(iii) SLSC considering in view of the demand for AOVN Scheme and taking opinion of TW

Department officials, suggested to fix target of 250 for the next year 2024-25.

(iv) Applications with below 2 years duration: The TWD officials have brought to the notice

that the tribal applicants and their parents have been approaching for consideration on the

similar lines of BCW Department for the students pursuing PG course below (2) years.

Accordingly, SLSC after examination, felt appropriate to consider to apply analogy on par with

BCW Department for the eligible applications pursuing PG abroad less than 2 years period.

Accordingly, a proposal to be submit to Government for consideration on par with **BCW** 

Department.

(v) <u>Issues relating to income on candidate's name</u>: There are (12) applications relating to

the income on the candidates name for which SLSC directed/decided to insist the applicants

that parental income shall be submitted in a specific time limit and after if they are found

eligible, they are to be considered for sanction, if not rejected. Accordingly, SLSC has decided.

(vi) <u>Issues / applications relating to invalid applications</u>: It is brought to the notice of the

SLSC, that there are (3) applications with invalid credentials, for which SLSC decided to insist

the applicants to submit credentials / documents within in a specific time, after if they are

found eligible, they are to be considered for sanction as per eligibility.
