At the outset, the Chairman SLSC & Secretary to Government, Tribal Welfare, TS has explained the guidelines of Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme as laid down in G.O.Ms.No.36 Tribal Welfare (Edn.-2) Department, Dt.04-06-2013 and also the process to be followed in selection of ST students for sanction of Financial Assistance to pursue higher studies in Foreign Universities, namely USA, UK, Australia, Canada, Singapore, Germany, New Zeeland, Japan, France and South Korea. During the meeting the Screening Committee has interviewed total 11 ST candidates.

As regards, achievements so far under this scheme till date (14) batches have been interviewed and 178 candidates have been considered for sanction of scholarship under Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme.

During 2020-21 (14th batch), total (11) students have registered their applications in e-PASS portal for sanction of Financial Assistance under Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme and 7 ST Candidates / Parents have attended for interview before the Committee on 30.09.2020. The Committee Members have scrutinized the original certificates and other related documents and interviewed the candidates and approved the following (04) ST candidates subject to caste verification from District Collector's concerned and Social Status verification by DTDOs concerned.
