At the onset, the Chairman, SLSC & Secretary to Government, Tribal Welfare, TG has explained the guidelines of Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme as laid down in G.O.Ms.No.36 Tribal Welfare (Edn.-2) Department, Dt.04-06-2013, G.O.Ms.No.66, SCD (Edn) Dept., Dt.9-11-2017 and G.O.Ms.No.62, Tribal Welfare (BUD & EDN.) Department, Dt.26.08.2021 and also the process to be followed in selection of ST students for sanction of Financial Assistance to pursue higher studies in selected 10 Countries Foreign Universities, namely USA, UK, Australia, Canada, Singapore, Germany, New Zealand, Japan, France and South Korea.

As per G.O.Ms.No.36 Tribal Welfare (Edn.-2) Department, Dt.04-06-2013, the Govt. have allotted total 100 seats towards 1st & 2nd batches every year @ 50 seats to each batch. During, 2024-25 the SLSC has been approved total 64 applications under 1st (fall) batch and remaining 36 kept for considered in the 23rd (spring) batch.

The SLSC examined the pending (04) applications of previous years and (68) applications of 23rd batch of 2024-25 (spring batch), which are for consideration and during the discussion, the TWD Officials have also brought certain additional points for examination and consideration in appropriate manner.

(i) Previous years (04) pending applications:

Total 04 applications of previous years were pending for want of VISA, required documents and due to absent for SLC. Details shown below:

State Level Screening Committee (SLSC) on AOVN scheme after detailed examination, following decisions have been taken:

The SLSC has been considered total 64 students candidature in 1st batch (fall) and remaining balance 36 candidates candidature under the annual target has been considered in 2nd batch (spring) for the year 2024-25.

The SLSC has been considered the candidature of the students from Sl.No.1 to 36 basing on the merit and directed to sanction financial assistance to the students as per the following directions:

1. Total (68) applications have been registered in e-pass from 14th October 2024 to 31st March, 2025 under 2nd batch (spring) of 2024-25, out of which (63) applicants submitted their certificates for verifications and (05) applicants have not submitted their certificates in this Office for verification in spite of intimation given to the individuals through this Official e-mail.

2. As against (63) candidates who have submitted their certificates for verification, out of which (07) applications are ineligible for sanction of financial assistance under AOVN scheme, due to the following reasons: (Annexure-I)
- Below 60% marks in Graduation : 04
 - Double Post Graduation : 01
 - Below 6 points in IELTS : 01
 - above family income limit : 01
3. Out of (56) eligible applications, (26) applicant names listed within the target of the merit list, who have 20 months & above period of course duration and out of (26) students (8) applicants have gap period 3 years and above between Graduation and Post Graduation. As per the orders issued in similar Gap issues vide G.O.Rt.No.169 TW (Bud. & Edn.) Dept., Dt.02.05.2025, the SLSC has directed to sanction the financial assistance @ Rs.20.00 lakhs to each student for pursuing higher studies at abroad. Details shown in Annexure-I.
4. (10) Students names listed within the target of the merit list, who have below 20 months of course period, the SLSC has directed to sanction the financial assistance in lines of the Govt. Memo No.3348/B/A1/2017, Backward Classes Welfare (B) Dept, Dt.29.05.2018 the orders issued in similar cases vide G.O.Rt.No.169 TW (Bud. & Edn.) Dept., Dt.02.05.2025. Details shown in Annexure-I.
5. After considering the 36 under the annual target of 2nd batch (spring) for the year 2024-25, balance 20 applications are examined by the SLSC and not considered as target is completed under the 2nd batch (spring) merit list of 2024-25. Details shown in Annexure-I.
6. The SLSC has been examined the following (4) previous batches applications and not considered as target is completed under the 2nd batch (spring) merit list of 2024-25. Details shown in Annexure-II.
