# Enhancement of Income Limit under the existing scheme of Skill Upgradation (Coaching for GRE/GMAT/TOEFL/IELTS):

- As per existing G.O.Ms.No.55 SW(Edn.I) Dept., Dated:29.06.2013, the family income limit of the student is less than Rs.2.00 Lakhs per annum for giving coaching to the students for appearing the exams i.e., GRE/GMAT/TOEFL/IELTS.
- The above scheme is feeder scheme for registration under AOVN.
- As per G.O.Ms.No.74 SCD(Edn) Dept., Dated:19.12.2017, the income ceiling limit to avail the benefit of scholarship under AOVN has been enhanced from Rs.2.00 Lakhs to Rs.5.00 Lakhs.
- Therefore, it is relevant to enhance the family income limit up to Rs.5.00Lakhs from existing Rs.2.00 Lakhs under Skill Up-gradation also to avoid the gap between the two schemes and to facilitate more registrations for AOVN.
