2) At the outset, the Commissioner(SCDD) welcomed all the State Level Committee members through GOOGLE MEET and informed that as on date (69) students have applied for sanction of AOVN grant and briefed the Committee members regarding the guidelines/orders issues by the Govt in G.O.Ms.No.54 dt. 25-6-2013 & G.O.Ms.No.66 dt. 9-11-2017, for sanction of AOVN grant.

3) The Commissioner(SCDD) has also explained to the Chairman & SLSC members that as seen from the year 2014-15, till date the target of 210 applications indicated every year are not being achieved and performance is very poor. The Dist SC Development Officers were instructed to give wide publicity to the scheme and see that the targets are achieved so that more SC candidates avails this prestigious scheme.

4) After thorough discussions the Commissioner(SCDD) has informed to the Chairman and SLSC members, that after scrutinizing the applications along with the documents the following were found eligible, needs relaxation orders and rejected.

a) As per scrutiny it is observed that the following (10) applications were found to be eligible for sanction of AOVN grant and requested the SLSC to approve the applications for sanction of AOVN grant. The Committee has agreed and approved the above (10) applications for sanction of AOVN grant. (Annexure-I).

- i) Some of the candidates have scored less degree marks, i.e. below 60%.
- ii) Some of the candidates have written only one qualifying exam i.e. GRE/GMAT/IELTS/TOEFL/PTE.
- iii) Some of the candidates have scored less marks in required tests i.e. GRE/GMAT/IELTS/TOEFL/PTE.
- iv) Some of the candidates have scored less marks in required tests, but got admission.
- v) Some of the students have not at all written the required tests but got admission.

6) Therefore, as per the above opinion of the Chairman/Secretary of SLSC, it has been proposed that a Committee consisting of the following members may be constituted for looking into the above details case by case and submit a report within (7) days so as to send necessary proposals to the SLSC for their decision in the matter.
