The Dy. Director (SCDD) is also requested to obtain declaration from the students / parents/ guardians duly verifying the certificates/documents such as I-20 etc.,

The following points are to be covered in a declaration form from the candidates / Parents / Guardian on stamp paper of Rs.10/- or Rs.20/- to the effect that the information provided is true/failing which liable to take further action besides cancellation / recovery / criminal action.

One Child: I am aware of the provision of one Scholarship only per one child per family and certify that I am the first child to avail this scholarship from my family.

Further, the concern DSCDO in requested to sanction AOVN scholarships as per the procedure& guidelines as follows.

- The DSCDO, **shall not sanction** the AOVN scholarships **until the candidate/parent uploads and submits the required certificates** such as I-94, VISA, ID Card and Affidavit etc., to the DSCDO concerned.
- After receipt of the I-94, immigration stamp, VISA, ID Card, Affidavit, fee paid receipt etc., from the candidate/parent concerned, the DSCDO concerned **shall personally verify the details** and enter the exact amount to be paid (OR) Rs.20.00 lakhs whichever is less as per I-20 and confirm the candidature in the epass website for sanction of AOVN scholarships.
- The DSCDO, concerned shall satisfy himself that the candidate has gone abroad and pursuing his studies duly verifying the exact fees (including living expenses if any) and sanction the AOVN scholarships as per the guidelines issued by the Govt. in G.O.Ms.No.54 SW (Edn.2) dept, dt.28-6-2013 and G.O.Ms.No. 66, dt. 09.01.2017.

- **The DSCDO, concerned is also to verify and satisfy himself before sanction of AOVN grant, whether the student is pursuing his studies in abroad keeping in view of COVID-19, as most of the students returned from various countries. The prescribed formats (I to III) is enclosed herewith for confirmation of the University/ College.**

The PMU is requested to issue necessary confirmation of the above candidate in the epass website so as to enable the Dy. Directors/DSCDOs, concerned to take necessary further action in releasing the amounts to the selected candidates.
