


2) At the outset, the convener welcomed all the State Level Committee members and briefed regarding preparation of Merit List of the students as per the guidelines issued in G.O. Ms. No. G.O.Ms.No:54 SCD (Edn) Dept., Dated: 28.06.2013, G.O.Ms.No.66 SCD (Edn) Dept., Dated: 09-11-2017 and G.O. Ms. No. 2 SCD (Edn.A1) Dept, Dt: 05-02-2021 as follows.


- i) Up to the last SLSC held on 25-10-2022, the SLSC has approved all the eligible SC students, who have fulfilled the conditions prescribed under the scheme, consequently (50) students who have been approved in the last SLSC, could not be permitted to sanction the Scholarship, due to exceeding the target of (210), and they have to be cleared in this financial year, 2023-24.
- ii) Hence the target for this session has been fixed to (80) students only, as the 25 reduced in this session and 25 to be reduced in the next session, out of the above 50.
- iii) For this financial year total (317) students have been registered under the scheme up to 03-04-2023, against to the Target of (210).
- iv) Hence, it has been decided to prepare Merit list of students as per the guidelines issued in G.O.Ms.No.66 SCD (Edn) Dept., Dated: 09-11-2017, i.e. 60% weightage on Degree Marks + 40% weightage on Test Scores GRE/GMAT/PTE/TOEFL/IELTS.
- v) 33% reservation for Women candidates and 10% for Humanities, Economics, Accounts, Arts and Law students.
- vi) Further, the SLSC has decided to consider the students whose duration of the Course is (24) months & above strictly for Post Graduate Courses, so as the student can get a quality of Masters Degree in Foreign Universities, to grab the best opportunities in their future career, and also for fruitful implementation of the scheme.
- vii) Further the (14) old students names are also placed before the SLSC, who have changed the Universities, Deferred in previous SLSCs subject to furnishing of pending documents, and the SLSC has taken the following decision:


- a) To send proposal to the Govt., in respect of (2) students i.e., 1. Netha Bharath, S/o Netha Rajam, Jagtial District and 2. Dara S Uday Kiran S/o Dara Satyanarayana, Rangareddy District , who changed universities after approval of the SLSC.
- b) Rejected the application of Ms. Raishetti Sucharitha D/O Raishetti Krishnaiah, Mahabubabad District, who has not changed as per the remarks of the SLSC held on 22.10.2022 Sl. No. (102), Annexure-III of the SLSC Minutes.
- c) Placed the remaining (11) old applications in Merit List.
- viii) Accordingly the Merit list was prepared with (317) Fresh students + (11) Old students= Total (328).
- ix) Further time line of one month is fixed for submission of pending documents by the students who are selected conditionally.

After scrutiny of Certificates of the candidates, the Committee has decided to recommend for sanction of Financial Assistance to the candidates who have course duration of 24 months & above and fulfilled the terms stipulated in G.O.Ms.No:54 SCD (Edn) Dept., Dated: 28.06.2013, G.O.Ms.No.66 SCD (Edn) Dept., Dated: 09-11-2017 and G.O. Ms. No. 2 SCD(Edn.A1) Dept., Dt: 05-02-2021, as per merit, appended herewith.
