- 2) At the outset, the Chairman welcomed all the State Level Committee members and requested the Director (SCDD) to call the students as per the list for interviews. The following documents pertaining to students who attended the SLSC were verified by the committee members.
 - GRE mark sheet
 - TOEFL mark sheet
 - I-20 issued by the respective universities
 - Mark sheet of Graduation Course
 - Passport/VISA
 - Caste certificate issued by the Mee-Seva
 - Income certificate issued by the Mee-Seva
 - Ration card
 - Aadhar card
 - Bank pass book
- 3) The Committee held detailed discussions regarding the authenticity of the accreditation of the Universities to which the candidates have applied and after examining the above documents, the Committee interviewed the candidates with reference to the all other eligibility norms.
- The Committee has observed that through the registrations are opened for all the days (throughout the year) some of the candidates have registered in e-pass portal with considerable delay even after the joining the course without giving any valid reason. In this regard the Committee has taken a view that, in all such cases the sanction of Financial Assistant is to be given in proportionate manner considering the semester as the unit taking the commencement of course and registration date in the e-pass portal into consideration (i.e., if the candidate register within first semester in the E-pass portal, there will not be any proportionate deduction).
- After scrutiny of Certificates and interview of the candidates and parents (who attended the interview on behalf of the candidate), the Committee decided to **recommend for sanction of Financial Assistance** to the following candidates who have fulfilled the terms stipulated in G.O.Ms.No:54 SCD (Edn) Dept., Dated: 28.06.2013, and G.O.Ms.No.66 SCD (Edn) Dept., Dated: 09-11-2017, subject to social status verification reports (as shown in Annexure-I).
