The State Level Screening Committee for selection of eligible ST students for sanction of financial assistance under Dr. B.R. Ambedkar Overseas Vidya Nidhi Scheme was held on 16.02.2021 at 11.00 AM at Conference Hall, 2<sup>nd</sup> floor, DSS Bhavan, MasabTank, Hyderabad. The following Officials have attended the meeting:

At the outset, the Chairman SLSC & Secretary to Government, Tribal Welfare, TS has explained the guidelines of Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme as laid down in G.O.Ms.No.36 Tribal Welfare (Edn.-2) Department, Dt.04-06-2013 and also the process to be followed in selection of ST students for sanction of Financial Assistance to pursue higher studies in Foreign Universities, namely USA, UK, Australia, Canada, Singapore, Germany, New Zealand, Japan, France and South Korea. During the meeting the Screening Committee has interviewed total 17 ST candidates.

As regards, achievements so far under this scheme till date (14) batches have been interviewed and 203 candidates have been considered for sanction of scholarship under Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme.

The following suggestions made by the Commissioner, SCD Department during the meeting.

4. Expressed her opinion on caste verification and suggested to conduct caste verification through the Director, TCR & TI to avoid delay in issuing of sanction proceeding to the eligible students. In case of any complaints or doubtful cases detailed enquiry may be conduct through concerned District Collectors.
5. Suggested to give awareness to the selected students to upload boarding pass and other Immigration/ I- 98, joining in University documents in e-pass in time so as to facilitate to release the 1<sup>st</sup> Instalment.
6. Flexi should be exhibited in front of council hall for indication detailed process of AOVN scheme and how to upload require documents in e-pass website.



The following suggestions made by the Commissioner, Tribal Welfare.

3. Instructed to adopt the separate software of AOVN which is using by the SCD Department.
4. They should not be any disparities in eligibility criteria in selection of ST students for AOVN Scheme.

During 2020-21 (15<sup>th</sup> batch), total (19) students have registered their applications in e-PASS portal for sanction of Financial Assistance under Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme and 17 ST Candidates / Parents have attended for interview before the Committee on 16.02.2021. The Committee Members have scrutinized the original certificates and other related documents and interviewed the candidates and approved the following (07) ST candidates.
