MINUTES OF THE 16TH STATE LEVEL SCREENING COMMITTEE MEETING FOR
SCREENING AND INTERVIEW OF THE CANDIDATES APPLIED FOR SANCTION OF
FINANCIAL ASSISTANCE UNDER Dr.B.R. AMBEDKAR OVERSEAS VIDYA NIDHI
SCHEME FOR THE YEAR 2021-22

The State Level Screening Committee for selection of eligible ST students for sanction of financial assistance under Dr. B.R. Ambedkar Overseas Vidya Nidhi Scheme was held on 16.07.2021 at 12.00 Noon at Conference Hall, 2nd floor, DSS Bhavan, MasabTank, Hyderabad. The following Officials have attended the meeting:

At the outset, the Chairman SLSC & Secretary to Government, Tribal Welfare, TS has explained the guidelines of Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme as laid down in G.O.Ms.No.36 Tribal Welfare (Edn.-2) Department, Dt.04-06-2013 and also the process to be followed in selection of ST students for sanction of Financial Assistance to pursue higher studies in Foreign Universities, namely at USA, UK, Australia, Canada, Singapore, Germany, New Zealand, Japan, France and South Korea.

As regards, achievements so far under this scheme till date (15) batches have been interviewed and 203 candidates have been considered for sanction of scholarship under Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme.

During 2021-22 (16th batch), total (34) students have registered their applications in e-PASS portal for sanction of Financial Assistance under Dr. B.R. Ambedkar Overseas Vidya Nidhi scheme, out of which only 13 ST students have fulfilled the required Govt. norms and were called for certificate and caste verification to the O/o CTW, TS, Hyderabad on 13.07.2021.

The Director, TCR & TI, Hyderabad has submitted caste verification reports and accordingly 13 Candidates / Parents have been called to attend the interview before the Committee on 16.07.2021. Only 8 ST Candidates / Parents have attended the interview and the Committee Members have scrutinized the original certificates, other related documents and approved the candidature of (08) ST candidates, details shown below:

As caste verification has already been done by the Director, TCR & TI,, Hyderabad only doubtful cases if any may be send to the concerned District Collectors for further enquiry and the list of selected 08 ST candidates may be sent to the DTDOs concerned for conducting social status enquiry within 10 days and submit the reports to this Office for sanction of Financial Assistance under "Ambedkar Overseas Vidya Nidhi" scheme.
